ACADEMIC, CULTURAL AND SCIENTIFIC AGREEMENT OF COOPERATION  
between the  
MASARYK UNIVERSITY, BRNO, CZECH REPUBLIC  
And  
UNIVERSIDADE FEDERAL DA BAHIA, SALVADOR, BAHIA, BRAZIL  
And  
UNIVERSITY OF NAMIBIA, WINDHOEK, NAMIBIA

With the objective of strengthening the ties of cooperation among Czech Republic, Brazil and Namibia, Masaryk University, hereinafter known as MUNI, represented, in this act, by the Rector, Professor Martin Bareš, the Universidade Federal da Bahia, hereinafter known as UFBA, represented, in this act, by the Rector, Professor Paulo Cesar Miguez de Oliveira, and the University of Namibia, hereinafter known as UNAM, represented, in this act, by the Vice Chancellor, Prof. Dr. Kenneth Matengu, do sign this Cultural, Educational, and Scientific Agreement of Cooperation.

CHAPTER I  
THE SCOPE OF THE COOPERATION

ARTICLE 1:

The areas of cooperation covered by this agreement include any field of knowledge, school, faculty, institute, department, centre or programme of extension or research that is considered to be of mutual interest and that can contribute to the achievement of the goals established by the Parties.

CHAPTER II  
THE AREAS OF THE COOPERATION

ARTICLE 2:

The following activities shall be promoted as priority items:

- a) Exchange of students at undergraduate and post-graduate levels;
- b) Collaboration between lecturers and researchers regarding the development of research;
- c) Promotion of scientific events;

d) Supervision and co-supervision of Master's dissertations and of Doctoral theses; participation in Examination Boards; and

e) Exchange of bibliographic material.

### CHAPTER III THE METHODS OF COOPERATION

#### ARTICLE 3:

Specific joint activities, the conditions for utilizing the results achieved from these activities, and arrangement for visits, exchanges, and other forms of cooperation will be developed mutually for each specific case through an Addendum Agreement.

### CHAPTER IV FINANCES

#### ARTICLE 4:

The present agreement does not imply any financial obligation on the part of any of the parties. Projects which involve the procurement and management of financial resources will be subject to an Addendum Agreements, wherein the parties involved must attach supporting documentation of the funding.

### CHAPTER V STUDENT EXCHANGE

#### ARTICLE 5:

Students participating in the exchange will pay academic fees at the home university and shall be exempted from payment of the regular courses at the host university. Any non-regular courses offered by the host institution, at the request of the home institution will be charged.

#### ARTICLE 6:

Participants in this agreement shall be entirely responsible for the costs associated with the issuance of visas, international travel, lodging, international health and repatriation insurance, food, local transport, acquisition of study material, and whatever personal expenses they perceive as being desirable or necessary throughout the period of exchange.

### CHAPTER VI THE INSTITUTIONAL REPRESENTATION

#### ARTICLE 7:

The administration of the activities undertaken within the terms of this agreement will be the

responsibility of the Rector's office at the MUNI; of the International Office at the UFBA; and the Corporate Engagement and International Relations Directorate at UNAM.

CHAPTER VII  
THE VALIDITY OF THE AGREEMENT

ARTICLE 8:

This Agreement will be valid for five (5) years from the date of its signature and may be renewed for further (5) five-year period, by mutual written agreement of the parties.

The Parties may rescind the present agreement by giving ninety (90) calendar days written notice to the other parties, without impediment to the activities, programmes, or projects being carried out on that occasion.

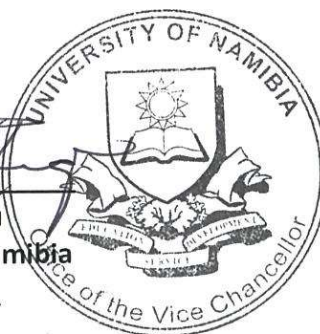
